2. Tender fee of Rs.200/-shall be deposited for tender document and EMD of 2% shall be deposited via cheque.
3. TDS shall be deducted as per Income Tax Rules.

4. The Services shall be provided within 10 days & confidentiality of the document shall be maintained.
5. Service provider shall attach GST registration certificate& partnership deed /any other, for company's registration certificate with quotation if any.
6. Tender must be properly sealed in double envelope duly marked tender for "Printing Work".
7. Undersign tender committee may refuse any tender without assigning any reasons.
8. Tender received after 3PM on date24-June-2021 shall not be considered.
9. The contract can be repudiated at any time in case unsatisfactory services.
10. Each page of tender needs to be dated & seal/signed by the Tenderers in token of acceptance of all the terms and conditions.
11. No other conditions except those mentioned above will entertained in the tender.
12. The number of pages in the books in the above table can be more or less by 1 to 10. The cost of printing shall not change on this basis.
13. The number of books has been kept minimum. In case more copies are required, they shall be printed by the concerned party as per the quotation now,
