3. That the Vidya Bhawan Public School is being run as a community service and not as a business and that commercialization does not take place in running the school in any manner whatsoever.

6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.

7. That the Principal and Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.

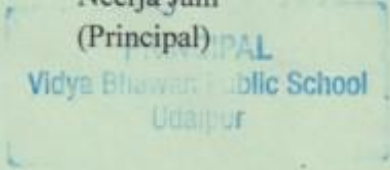
8. That the school will ensure compliance of all statutory requirements like EPF,ESI and Labour Laws etc. with respect to the school and staff of the school.

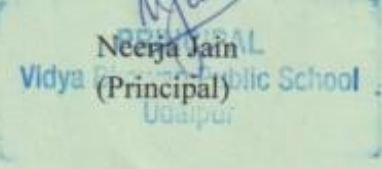
