- iii- An Applicant should have valid PAN, TIN, GST as applicable (if required)
- iv- The offerer may be asked to check the sample.
- v- Applicant has to submit self-certified copy of all the relevant documents.

GENERAL TERMS AND CONDITIONS

01- PROCEDURE FOR TENDER

- 1.1 The Institute invites the tender for supply of Breeding Bucks (Sirohi Breed).
- 1.2 Only one offer will be accepted from any Applicant.
- 02- It is the discretion of the Senior Scientist and Head of the Institute to accept/reject the application without assigning any reason thereof.

03- AVAIBILITY OF TENDER DOCUMENT

After depositing Rs. 200/- the document can be taken from the institute in office hours. The tender document can be download from www.vidyabhawan.in and fee can be deposited before submission of tender in cash at office.

04- SUBMISSION OF TENDER

- 4.1 The Tender shall be submitted in Three Envelopes, Envelope A (Technical information regarding eligibility), B (Financial offer Annexure 5 only) and Envelop C containing (Both A and B)
- 4.2 Envelope C shall be submitted in a sealed cover super scribed with words "Tender of Supply of Breeding Bucks (Sirohi Breed)"

05-EARNEST MONEY DEPOSIT

Bhatnego

Applicant has to deposit required Earnest Money Deposit (2%) by way of demand draft in favor of "Vidya Bhawan Krishi Vigyan Kendra" payable at Udaipur. It can also be deposited by cash at the time of submission of tender document.

- (i) Earnest Money of all unsuccessful Applicants will be returned to their account (as per cancelled cheque attached by you) only (irrespective of any mode of payment used for submission of EMD). No interest is payable on the amount of EMD at the time of refund.
- (ii) Earnest Money shall be forfeited if the offer is withdrawn.
 - a. At any time prior to its rejection,
 - b. Before or after the acceptance is communicated to the Applicant.
 - c. If the selected Applicant fails to execute the agreement within prescribed time limit.
 - d. If it is found that false documents/information are submitted.
- (iii) The EMD will remain with the Institute during the currency of the contract and/or till successful execution of all the order placed during the currency of the contract and will be refunded to the supplier without interest in case of no dispute.
- (iv) Earnest money of successful Applicant will be adjusted against Security Deposit (SD) at the time of the execution of the said work.





06-SECURITY DEPOSIT (SD):

- (i) The amount of EMD will be adjusted as SD for the successful applicant. The Security deposit will remain with the Institute during the currency of the contract and will be refunded to the supplier without interest in case of no-dispute.
- (ii) Security deposit will be forfeited in case of failure of supply of the material as mentioned in the supply order, in time and as per the approved specifications or for any breach of terms and condition of the agreement and tender.
- (iii) The security deposit will be refunded after the successful execution of all supply orders during currency of the contract period provided no dispute; claims or complaints exist for settlement without interest.

07-TECHNICAL SPECIFICATION

- (i) The technical specifications of the Breeding Bucks are attached separately
- 08- LOCAL CONDITIONS: It will be imperative on each applicant to fully inform himself of all local conditions and factors which may have any effect on the execution of the works. Institute shall not entertain any request for clarifications from the Applicant, regarding such local conditions.

09 - QUOATING OF RATES

- 1. Applicant has to quote Final selling rates to the Institute i.e. the rates must include the cost of material, cost of transportation, loading, unloading and all the taxes whatsoever and Institute margin, F.O.R. destination.
- 2. The rates must be quoted both in words and figures. In case of difference in words and figures of the rates quoted, the rates offered in words shall be considered.

10- REASONABILITY OF RATES:

Applicant shall have to offer his lowest rates for the offered item and it should be strictly in accordance with the clause mentioned below:

- (i) The price charged for Items under this contract by the Applicant shall in no event exceed the lowest price at which the identical items to any other person /organization/ government department/ Govt. Institute / or any Govt. body in Rajasthan during the period till completion of all orders issued during the currency of contract is completed.
- (ii) If at any time during the said period the Supplier reduces the sales price of such offered items or sells such items to any other person / organization at a price lower than the price chargeable under the contract, the Supplier shall forthwith notify such reduction in the rate to the Institute. The price paid under the contract after such reduction in sale price, shall stand correspondingly reduced. The Institute shall be entitled to recover such excess amount.
- 11 -NEGOTIATIONS: It is clarified that normally, no rate negotiation will be done and therefore the Applicant should quote their lowest prices only. However, the Senior Scientist and Head may decide to negotiate the rates in exigencies required to do so.



12-VALIDITY OF TENDER: Application received in against this tender is valid for acceptance upto February 2024 of Submission.

13- VALIDITY OF CONTRACT: The Contract against this Tender is valid up to successfully execution of supply orders.

14- AWARD OF CONTRACT: The institute shall notify the successful applicant by issuing a 'Purchase Order' that his tender has been accepted.

15-SCHEDULE AND MODE OF SUPPLY / PAYMENT

The supplier has to start supply the ordered within 10 days from the receipt of order of the institution. The payment shall be released on "Payment after Payment" basis after deducting T.D.S. and SD as per following manner:

15.1 PAYMENT

- Payment will be made after delivery and satisfaction regarding quality of material.
- 2. 2% EMD and 5% SD of total amount would be deducted in first supply and would be released after supply of the said quantity in good condition at the desired site of the consignee.

16-SUPPLY

- 1- The supplier shall ensure that the ordered material in all as per order supplied by him reaches to the consignee at destination in good condition.
- 2- Failure on the part of the supplier for timely supply/installation, may lead to forfeiture of the Security Deposit and the rate contract shall stand cancelled and agreement terminated.
- 3- If any dispute regarding the quality / quantity of the material supplied, the institute will make payment after settlement of the dispute only.
- 4 Electric Work: Required electric appliance require for the work will be carried out by the supplier and electricity will be supplied by the institution.

17 - INSURANCE AND COMPENSATION:

- a. The Supplier will arrange for Transit Insurance and Material supplied should be covered under Transit insurance for Road Risk, Theft, Pilferage, and Non Delivery Risk (RRTPND).
- b. The Supplier has to fulfill all the provisions mandatory or obligatory under workmen compensation Act Payment of minimum wages act. Supplier have responsibility of Employee State Insurance schemes or any other labour laws in regards to the welfare of the workers engaged by the supplier for the purpose of the fulfillment of contract under tender. Any award, compensation for injury or death of any worker/employee or other person, penalty etc shall be the responsibility of the supplier. However, if the corporation is required to make payments on these accounts the same shall be recovered from suppliers.]

18 -WARRANTY & WARRANTY PERIOD

19-TESTING FOR QUALITY

As per the specification of breeding buck's expert team will cheke.

20- PENALTIES

- 1. If supplies are not made in time, the Senior Scientist and Head may accept delayed supplies with due concern of the purchaser department only, after imposing penalty as per the decisions of purchasing department if any.
- 2 The Senior Scientist and Head reserves the right to impose penalties at his discretion for breach of the terms and conditions (commensurate with the losses incurred) which may be forfeiture of SD and/or debarring the supplier for maximum period of 5 years to supply all materials, whatsoever may be, through this corporation.
- 21- The Senior Scientist and Head reserves the right to accept or reject any or all the application without assigning any reason whatsoever at any time prior to the award of the contract, without incurring any liability to the affected Applicant and any obligation to inform the affected Applicant of the grounds.

बकरा खरीद हेतु मुख्य वाते

- (1) बकरे की नस्ल सिरोही होनी चाहिये। बकरे का रंग गहरा भूरा एवं भूरे रंग पर पीले धब्बे रंग को वरीयता प्रदान की जावेगी। मुंह पर सफेद रंग नहीं होना चाहिये।
- (2) बकरा बीजू होना चाहिये, ताकि नस्ल सुधार हेतु उपयोग में लिया जा सके।
- (3) बकरे का न्यूनतम वजन 35 किलोग्राम होना चाहिये। अतिरिक्त भार होने पर अतिरिक्त राशि देय नहीं होगी।
- (4) बकरे की उम्र 1 से 1½ वर्ष के बीच होनी चाहिये। चार दांत से कम उम्र का होना चाहिये।
- (5) बीजू बकरे का चयन क्रय–विक्रय समिति द्वारा किया जावेगा। बचे हुए वकरे पार्टी स्वयं को वापस ले जाना होगा।
- (6) बीजू बकरों का भुगतान बकरें केन्द्र पर पहुंचने के 15 कार्य दिवस में खाते में किया जावेगा। इन 15 कार्य दिवस में यदि किसी भी बकरें की मृत्यु होती है तो उसका भुगतान घटा कर किया जावेगा।
- (7) बकरे के कृषि विज्ञान केन्द्र, बड़गांव तक को पहुंचाने की जिम्मेदारी चयनित पार्टी की होगी।
- (8) बकरे की अन्तः एवं ब्राह्म कृमिनाशक करने के पश्चात् देना होगा। सभी प्रकार का टीकाकरण करके देना होगा। यह दोनो कार्य केवीके पर बकरे आने के पश्चात् ही करना होगा।
- (9) बकरे का वजन कृषि विज्ञान केन्द्र पर क्रय—विक्रय समिति के समक्ष होगा। 35 किलोग्राम से कम के बकरो को चयन नहीं किया जावेगा।

- (12)बकरे का भुगतान पार्टी के बैंक खाते में किया जावेगा।
- (13)यदि चयनित पार्टी बकरे सप्लाई करने में सक्षम नहीं रहती है तो क्रय-विक्रय समिति एवं अधोहरताक्षरकर्त्ता यह कार्य दूसरे नम्बर की वरीयतापार्टी को नियमानुसार हस्तान्तरित करने का अधिकार रखती है।
